

**INSTRUCTIONS FOR STOCKHOLDERS OF OPPENHEIMER HOLDINGS INC.  
TO REMOTELY ACCESS, PARTICIPATE IN AND VOTE AT  
THE VIRTUAL ANNUAL MEETING OF STOCKHOLDERS  
TO BE HELD ON MAY 9, 2022 AT 4:30 P.M. EASTERN TIME**

The location of the 2022 Annual Meeting of Stockholders of Oppenheimer Holdings Inc. will be held over the internet in a virtual meeting format only. You will not be able to attend the 2022 Annual Meeting in person. If you were a holder of record of our Class A non-voting common stock or Class B voting common stock at the close of business on the record date of March 11, 2022, you are eligible to attend the meeting. To attend the virtual annual meeting, stockholders will need access to an internet-connected device for the full duration of the virtual annual meeting. Instructions follow:

Holders of Class A non-voting common stock may log in and listen and view the meeting as a “**Guest**.” If you wish to submit questions in advance for consideration and response at or after the meeting, please email [info@opco.com](mailto:info@opco.com).

Holders of Class B voting common stock may log in and listen and view the meeting as a “**Guest**,” but will not be able to vote on all business properly brought before the meeting and/or submit questions online during the meeting for consideration and response during or after the meeting. If you wish to submit questions in advance for consideration and response at or after the meeting, please email [info@opco.com](mailto:info@opco.com).

Holders of Class B voting common stock who wish to vote on all business properly brought before the meeting and/or submit questions online during the meeting for consideration and response during or after the meeting must join as a “**Shareholder**.”

To join as a “**Shareholder**,” you will be required to have some additional information including your annual meeting control number listed in the gray bar on your proxy card.

- **If you are a holder of Class B Voting common stock and hold your shares through a broker, bank or other intermediary** and want to join the meeting as a “**Shareholder**,” you must register in advance by 4:00 p.m. Central Time on Wednesday, May 4, 2022. To do this, you must request a legal proxy. A legal proxy can be obtained by logging into the voting site listed on your Voter Instruction Form and clicking on “Vote in person at the meeting” or requesting one through your broker. Once received, you must send an email to [legalproxy@computershare.com](mailto:legalproxy@computershare.com) and include an image of the legal proxy in your name from the broker, bank or other nominee that holds your shares and your address. By completing this process, you will receive an annual meeting control number from our Virtual Meeting provider.
- If you are a holder of Class B voting common stock and hold your shares through our transfer agent, Computershare, you do not need to preregister. The annual meeting control number will be listed in the gray bar on your proxy card.
